Cap city employee salaries . Some are making over 200K

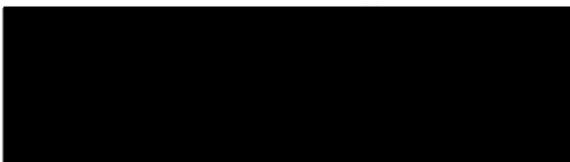
Eliminate lifetime pensions. Enroll city employees in social security , 401 K and IRA plans like the private sector.

The undersigned proponent(s) or author(s) of the (primary/rebuttal) argument (in favor of/against) ballot measure relating to the one and one-half cent (1.5%) sales tax (transaction and use tax) at the General Municipal Election for the City of Los Alamitos to be held on November 3, 2020 hereby state that the argument is true and correct to the best of (his/her/their) knowledge and belief.
